AGREEMENT, WAIVER AND RELEASE

In consideration of being admitted by the Mountain View Russian Orthodox Church – MVROC, Inc. as a participant, I hereby waive, release and discharge any and all claims for damage for personal injury, sickness, death or property damage which I may have, or which may hereafter accrue to me, as a result of attending the youth conference in person, and participating in activities in the religious center facilities and outside of them.

The World Health Organization has declared (*COVID-19"). COVID-19 is extremely contagious and it is believed to spread mainly from person-to-person contact.

While rules, guidance, and personal discipline may reduce this risk; **the risk of serious illness and death does exist.** Mountain View Russian Orthodox Church – MVROC, Inc. cannot completely mitigate the transfer of communicable diseases like COVID-19 especially when involved in lectures, church services, meals, skiing, or any other conference activities.

Participation in these school activities include possible exposure to illness, injury, or death from infectious diseases, including COVID-19.

In consideration for providing me/ my child the opportunity to participate in the 2022 Russian Orthodox Youth Conference and its activities, any related transportation to and from these activities, both my child and/or I voluntarily agree to waive and discharge any and all claims against Mountain View Russian Orthodox Church – MVROC, Inc., and release it from the liability for any exposure to, or injury from an infectious disease including COVID-19, including claims for any negligent actions of the Center/School or its employees or agents, to the fullest extent allowed by law, for myself, my child, our estates, our heirs, our administrators, our executors, our assignees, and out successors.

I also agree to release, exonerate, discharge and hold harmless Mountain View Russian Orthodox Church – MVROC, Inc., its Board of Directors, the individual members thereof, and all officers, agents, administration, volunteers, other participants, and representatives from all liability, claims, causes of action, or demands, including attorney fees, fines, fees, or other costs (e.g. medical costs) arising out of any exposure to or illness or injury from an infectious disease including COVID-19, which may result from or in connection with me or my child's participation in any activities.

I further certify and represent that I have the legal authority to waive, discharge, release, and hold harmless the released parties on behalf of myself, or the above-named student. If Participant is a minor).

I certify that I have carefully read this document in its entirety and fully understand its contents. In exchange for the opportunity to participate in the youth conference activities, the above-named participant and I freely and voluntarily assume all risks of such hazards and notwithstanding such, release Mountain View Russian Orthodox Church – MVROC, Inc., from all liability for any loss regardless of cause, and claims arising from the participants involvement in the youth conference and all activities.
